PTG Treasurer Report 2015-2016

FUN DAY is the biggest event of the year. It was a success and measured by the visitor's satisfaction. A big Thank You to Everyone involved. The event generated an income slightly higher than the previous year. Receivable accounts from Vendors and Sponsorship amounting to 94,300 Baht are expected to be received in April.

TIGER SHOP – A general inventory was done in the middle of this academic year. Information was provided showing individual stock items, quantity, cost price, sell price, total cost price and total sell price. The Cash System to an English language option is still in process. Planning for new orders were leaned to the following year.

CHRISTMAS CONCERT – the Annual Concert signifies the spirit of Music and Togetherness. It created warmness and an enjoyable evening for the School Community. Following the success of the event, new requests for more selections of Food and beverage will be considered for the next year.

OPERATING EXPENSES illustrates the scale of PTG's success. Distribution of Expenses concentrates on the Annual Administration costs, Fun Day, Grants, Social Activities, CAT Community Donations, One-Off Donations & other contributions to the School and other related Activities as part of the Annual PTG on-going projects. Outlining them explains how rewarding the current year is.

PROPOSED BUDGET - Allocations for the new Proposed Budget and Reserved Funds were planned for the next calendar year. Thank you to the Committee input. As discussed at the Budget Meeting before the Songkran holidays, attached is the Proposed Budget 2016-2017.

INCOME BUDGET : Based on the figure below from the Two major components: Revenues & Expenses. Shows a LOSS or a Negative Income.

PTG expenses for the next School year increases with new additional proposed allocations. It requires more than 2.5 million to cover the costs next calendar year. PTG holds on-going expenses. To support these projects annually, RESERVE FUNDS are important. Considering the unknown outcome of how much profit PTG will generate the next Fun Day, **recommendation** to keep the existing amount and focus not to exceed from the allocated Budget until the Fun Day event is over. To keep an Annual Reserve Funds of 2 million Baht to cover the major PTG on-going projects is vital. PTG Committee will review the proposed budget once again and will decide whether to support any additional expenses and how much Reserve Funds for the next calendar year.
